#### 3. TRAINING OPPORTUNITIES

**Diversity Description:** Clients have multiple facets with regards to diversity. Some of these include but are not limited to their abilities, SES, diagnoses, religion, gender fluidity, sexual orientation, and ethnicity. (Spanish speaking is available if this is a specific training goal)

**Typical Presenting Problems:** Trauma (specifically sexual abuse), ADHD, Anxiety, Depression, OCD, PTSD, Gender transition, Autism, Divorce, Grief and loss, and School related issues with assessment based consultation.

**Therapy:** Treatment takes place in a private practice office located on a bus route and off multiple freeways. Students will build a client case load that keeps in mind their specific training goals. Depending on the trainees goals, there is a strong possibility of running a small group for children or teens. Clinical responsibilities include: scheduling, all necessary intake paperwork and write up, appropriate documentation (case notes, phone calls), billing, working

with insurance companies and case management based on client needs. Supervision is scheduled for up to 2 hours per week. Informal consultation during office hours is encouraged. **Assessment:** Students are involved in all stages of the therapeutic process with clients. This may include a variety of in office paper pencil assessments which are scored, reviewed with parents, and recommendations made. Consultation with school psychologist and understanding and reviewing the testing in the school environment is also a part of this training.
