3. AGENCY MISSION

To provide evidence based substance use disorder treatment to severely and chronically opioid dependent adults, and to provide prevention services that are designed to reduce risk factors and enhance resiliency factors in adults, youth, and children. We use an integrated approach to treatment and prevention services that addresses all of the bio-psycho social aspects of addiction in order to strengthen the quality of personal, family and community life. The geographical boundaries at the Salt Lake program are the greater Salt Lake County area and the boundaries at the Provo program span Utah County.

4. CLIENT POPULATIONS SERVED

Adults 18 and over; Opioid Dependent population in an outpatient Medication Assisted Treatment (MAT) setting.

5. TRAINING OPPORTUNITIES

We offer individual, group therapy services (couples, families limited during COVID19). We use shadowing approaches for trainees and students during intake process and day to day operations.

6. SPECIAL PROGRAMS/UNITS (LOCATION, FUNCTION)

Salt Lake is our main/largest program and we see 400 patients there with our lab that does the urinalysis testing. Our patients are required to come in daily for their medication dosing and we have a team of therapists, counselors, caseworker, nurses, physician's assistants who all collaborate to offer individualized care.

7. SPECIFIC DAYS/HOURS/TRAINING/ASSIGNMENTS REQUIRED OF STUDENTS

3 days/week, 15-16 hours for 1st year and 20-25 for second year. We typically prefer students to at least be there full day Monday 5:45 am-2pm (our staff meeting offers a lot of important training and that starts at 11 am and ends at 2). The other 2 days are typically Thur/Fri or Tue/Wed from 5:45 am-10 am. When students have shadowed and trained enough, we will assign them their own intake day on the schedule, they may be asked to take intake calls and schedule, they will be assigned a small caseload (5-10 patients) to begin the therapy

relationship with, when we do facilitate groups—students are coupled with a therapist to facilitate those groups. We will explore macro and any other projects with the students during supervision.

8. QUALITIES WE LOOK FOR IN A PRACTICUM STUDENT

A student who seeks supervision (even outside of scheduled supervision weekly), asks a lot of questions, reliable, eager to learn about our model, interest in long term therapy and psychodynamic theory and concept.
