# **Qualifications:**

Current graduate student in CMHC, PhD, or MSW program Counseling experience Strong references Experience and/or interest in feminist multicultural therapy, trauma therapy, and group therapy

# **Requirements:**

- Internship is for two full semesters, August 2021-May/June 2022 (preferred)
- Complete 40-hour state-certification training on issues of sexual violence. (*Training offered at RRC in June 2021, UCASA may offer other training dates*)
- Complete the Feminist Multicultural Therapy course offered Summer term 2021 through the University of Utah Women's Resource Center (encouraged but not required)
- Work at least 20 hours-32/week, including Group Internship Consultation (2x per month), Clinical meeting (Wednesdays 1-2pm), Clinical Training Seminar (Wednesdays 2-3pm). Office/virtual services are open Monday-Thursday 9am-7pm. Work at least 1-2 evenings.
- Will primarily work with clients in advocacy, and individual/group therapy.
- Opportunities in community outreach, volunteer training, and other RRC projects.
- BIPOC and bilingual/multilingual students are encouraged to apply.

#### Stipend:

Dependent on grants and funding availability.

#### What we offer:

- A supportive, energetic, highly collaborative work environment.
- Training and experience in working with survivors of sexual violence and trauma
- Opportunities to engage in group creation, specialized projects, and creative approaches to outreach
- Training in feminist, multi-cultural and trauma-oriented approaches to therapy.
- Excellent supervision: Students will receive 1 hour of individual supervision weekly, 1 hour of internship group consultation (2x per month), as well as supervision/case consultation in clinical meetings, provider meetings, and all staff meetings.
- Participation in clinical team trainings and retreats that focus on team development, self-care, trauma stewardship, and professional development.
